3. Graduate Students Association Reports and Questions / Rapports et questions de Association étudiantes des cycles supérieurs

a) Mees Brenninkmeijer (GLSA President)

- i) Wants to join forces with LSA with things that are happening at the faculty. GLSA is concerned with things around academic freedom. It wants to be a force in the faculty.
- ii) They will be voting on a motion next week about McGill's injunction that it sought a week ago.
- iii) First step towards GLSA knowing what the LSA is doing and the other way around.
- iv) LSA President said that the last motion had gotten a reply, which is rare. New events are all canceled by McGill Central until the end of the semester. Pénélope says that if anyone has any comments, they can email her.
